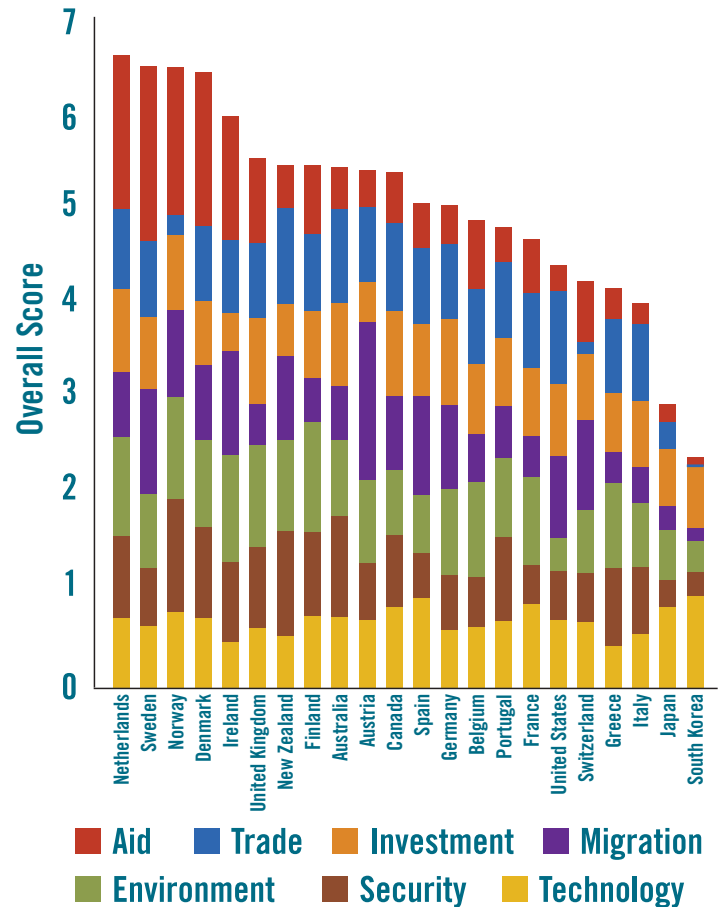
The Commitment to Development Index (CDI) ranks 22 of the world's richest countries based on their dedication to policies that benefit poor nations. Looking beyond standard comparisons of foreign aid flows, the CDI measures national effort in seven policy areas that are important to developing countries: aid, trade, investment, migration, environment, security and technology. This report reviews the Netherlands' performance on the 2008 CDI.

Netherlands' 2008 CDI Performance

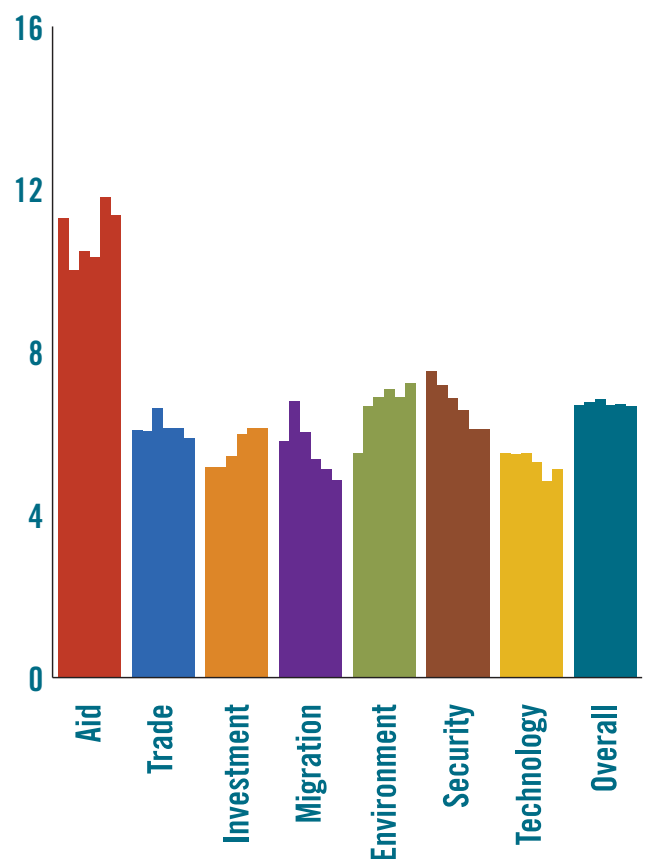
- Overall rank 2008: 1
 - Overall score 2008: 6.7
 - Change since 2003: 0.0
- (using 2008 methodology)

The Netherlands ranks 1st overall in 2008. The Netherlands places in the top half of CDI countries in all components except for migration. It gives a large amount of aid as a share of its income, and the quality of its aid is high. The Netherlands also has policies that promote productive investment in poor countries as well as a strong environmental record from the perspective of developing countries. Its score on the migration component is driven down by the relatively small number of immigrants from developing countries entering the Netherlands.

Aid

Aid quality is just as important as aid quantity, so the CDI measures gross aid as a share of GDP adjusted for various quality factors: it subtracts debt service, penalizes “tied” aid that makes recipients spend aid only on donor goods and services, rewards aid to poor but relatively uncorrupt recipients, and penalizes overloading poor governments with many small projects.

■ **Score: 11.4**

■ **Rank: 2**

Strengths

- Very high net aid volume as a share of the economy (0.76%; rank: 3)
- Selectivity: large share of aid to poor recipients with relatively democratic governments (rank: 1)
- Large amount of private charitable giving attributable to tax policy (rank as a share of GDP: 10)
- Prevents project proliferation; large average project size (rank: 6)
- Small share of tied or partially tied aid (4%; rank: 6)

Trade

International trade has been a force for economic development for centuries. The CDI measures trade barriers in rich countries against exports from developing countries.

■ **Score: 5.9**

■ **Rank: 5**

Weaknesses

- High tariffs on agricultural products (38.7% of the value of imports; rank: 8)
- High agricultural subsidies (equivalent to 8.0% tariff; rank: 4)

Investment

Rich-country investment in poorer countries can transfer technologies, upgrade management and create jobs. The CDI includes a checklist of policies that support healthy investment in developing countries.

■ **Score: 6.1**

■ **Rank: 4**

Strengths

- Provides insurance against political risk for both domestic and foreign firms
- Employs foreign tax credits to prevent double taxation of corporate profits earned abroad
- Participates in the Extractive Industries Transparency Initiative (EITI) and the Kimberley Initiative on blood diamonds
- Provides support for outflows of portfolio investment

Migration

The movement of people from poor to rich countries provides unskilled immigrants with jobs, income and knowledge. This increases the flow of money sent home by migrants abroad and the transfer of skills when the migrants return.

■ **Score: 4.9**

■ **Rank: 12**

Strengths

- Large increase during the 1990s in the number of unskilled immigrants from developing countries living in the Netherlands (rank by share of population: 9)
- Bears large share of the burden of refugees during humanitarian crises (rank: 6)

Weaknesses

- Small share of foreign students from developing countries (46%; rank: 19)
- Tuition for foreign students higher than for nationals
- Small number of immigrants from developing countries entering the Netherlands (rank by share of population: 15)

Environment

Rich countries use a disproportionate amount of scarce resources, and poor countries are most vulnerable to global warming and ecological deterioration, so the CDI measures the impact of policies on the global climate, fisheries, and biodiversity.

■ **Score: 7.2**

■ **Rank: 5**

Strengths

- Decline in greenhouse gas emissions in 1996–2006 (average annual growth rate/GDP, -3.1%; rank: 7)
- High gas taxes (\$1.07 per liter; rank: 3)
- Low fishing subsidies (\$0.03 per person; rank: 5)

Weaknesses

- High greenhouse gas emissions rate per capita (12.8 tons of carbon dioxide equivalent; rank: 15)

Security

Since security is a prerequisite for development, the CDI rewards contributions to internationally sanctioned peacekeeping operations and forcible humanitarian interventions, rewards military protection of global sea lanes, and penalizes arms exports to poor and undemocratic governments.

■ **Score: 6.1**

■ **Rank: 7**

Strengths

- Significant financial and personnel contributions to internationally sanctioned peacekeeping and humanitarian interventions over last decade (rank by share of GDP: 7)
- Military ships stationed in sea lanes that are important to international trade (rank by share of GDP: 4)

Technology

Rich countries contribute to development through the creation and dissemination of new technologies. The CDI captures this by measuring government support for R&D and penalizing strong intellectual property rights regimes that limit the dissemination of new technologies to poor countries.

■ **Score: 5.1**

■ **Rank: 10**

Strengths

- High government expenditure on R&D (rank by share of GDP: 9)
- Small share of government R&D expenditure on defense (0.2%; rank: 10)

Weaknesses

- Offers patent-like proprietary rights to developers of data compilations, including those assembled from data in the public domain

This table ranks the 22 countries in the CDI, showing their scores in seven policy areas. A country's overall score is the average of its seven policy scores. The final column shows the change in each country's overall score since the CDI began in 2003, using 2008 methodology.
