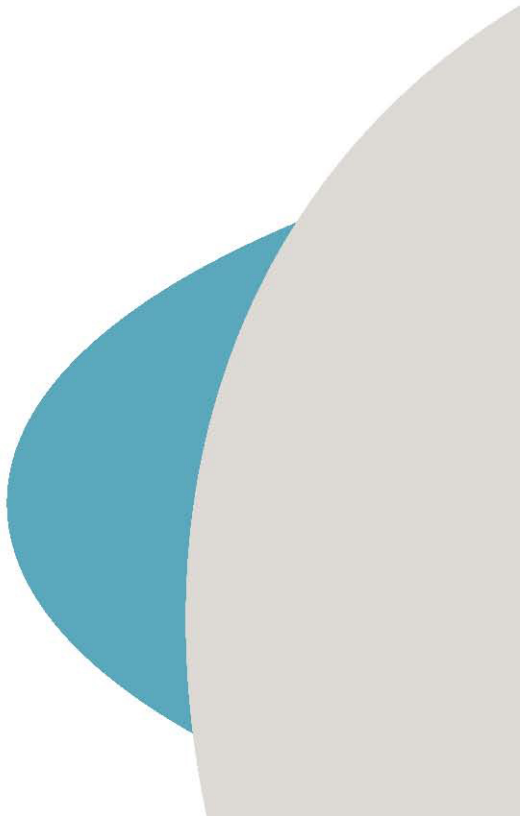

## Frequently Asked Questions

### Who are members of the Partners Council?

The Partners Council's membership includes firms and individuals. Individual members come from a wide variety of backgrounds, including politics, academia, philanthropy, and the private voluntary sector. Corporations are drawn from a wide range of business sectors, including financial services, law, energy, consulting, technology, and media.

### For corporate members, who makes decisions about membership in the Partners Council?

Each member corporation designates one executive to serve as a liaison between the company and CGD. This liaison or primary contact provides CGD information about the company's development-related interests, so that we can customize the resources and services that we offer. The primary contact also identifies executives to receive event invitations and subscriptions to newsletters, and may nominate executives to participate in special activities.

### How can I get information about upcoming events?

Invitations for CGD events are sent via email to Partners Council members. A quarterly e-newsletter, *The Partnership*, also highlights upcoming events, past activities, and updates on areas of interest to the members.

### What is the annual Partners Council Summit?

Held on the second Tuesday of each November, the Partners Council Summit is a half-day, off-the-record meeting where fellow members can interact with each other, CGD experts, and high-level external guests around a common agenda in development. Previous guest speakers have included Madeleine Albright, Tony Fratto, David Gergen, and Alice Rivlin.
